ABOUT AIR & GROUND AMBULANCE PAYMENT VALIDATION

Air and ground ambulance bills are among the most consistently inflated charges in workers' compensation. Hidden fees, unbundled services, and unsupported add-ons frequently drive billed amounts far beyond what is reasonable or defensible.

In many states, ambulance services fall outside established fee schedules, creating an environment where charges are dictated by billing practices rather than cost reality. Without independent validation, excessive reimbursement becomes normalized.

Air & Ground Ambulance Repricing exists to bring accuracy and discipline to these high-risk bills. By validating ambulance reimbursements at the line level and applying defensible pricing standards based on objective reimbursement standards, Comp42 ensures recommendations reflect what the transport should reasonably cost, not what was billed.

LINE-LEVEL AMBULANCE PAYMENT VALIDATION

Each charge is reviewed to confirm pickup and drop-off locations, mileage accuracy, and appropriate service levels.



UNBUNDLING AND ADD-ON REVIEW

Inclusive services are identified and corrected to prevent separate billing of charges that should not stand alone.



WHY AMBULANCE BILLS REQUIRE CLARITY

Ambulance billing leaves little room for interpretation once the facts are examined. Either the transport was necessary, the service level was appropriate, and the charges were supported, or they were not.

Air & Ground Ambulance Repricing replaces assumption-driven payment with line-level clarity. Recommendations are grounded in independent payment validation and validated against objective reimbursement standards, allowing them to remain consistent when examined by providers, auditors, or regulators.

When inflated and unsupported charges are corrected, significant reductions are frequently observed, with savings of up to 80% off the billed amount on eligible ambulance bills. More importantly, reimbursement recommendations remain defensible without negotiation because they reflect reality.
