FINANCIAL RISK PROTECTION

Shield provides financial protection related to provider disputes on covered workers' compensation medical bills, reducing unexpected exposure tied to extended dispute resolution.



ALIGNMENT WITH BILL REVIEW AND REPRICING

Shield is applied in conjunction with Comp42's payment integrity solutions and repricing services, ensuring protection is grounded in accurate, line-level recommendations.



WHY PROTECTION FOLLOWS ACCURACY

Shield is not designed to offset aggressive or unsupported reimbursement decisions. It is designed to reinforce recommendations that are already accurate, measured, and defensible.

Because Shield is paired with detailed payment integrity solutions, consistent methodology, and documented rationale, it is applied only when recommendations reflect reality. This alignment reduces prolonged negotiation, limits financial uncertainty during disputes, and supports resolution without shifting responsibility back to the payor.

Shield does not eliminate disputes. It reduces the financial risk they create.



SELECTIVE CASE APPLICATION

Shield is applied on a case-by-case basis, allowing Comp42 to assess suitability based on bill complexity, jurisdictional considerations, and dispute risk.
